For example,
Though she is black yet she is beautiful.
Though he is rich yet he is dissatisfied.
Thus, it is clear that among the given options, only (a) is correct.

Now, when an interrogative sentence is changed into an assertive sentence, we do not use ". asked that"- rather we simply use 'asked'. Option (b) can be rejected.

The use of 'would I' in option (d) is wrong because such structure is used in interrogative sentence not in assertive sentence.

Therefore, option (d) can easily be rejected. We are now left with option (c), which is absolutely correct.

For a bigger place we use ' $i n$ '. Hence (c) is correct.
