

The governor inaugurates the state legislature by addressing it after the assembly elections and also at the beginning of the first session every year.

The governor's address on these occasions generally outlines new policies of the state government. A bill that the state legislature has passed, can become a law only after the governor gives assent. The governor can return a bill to the state legislature, if it is not a money bill, for reconsideration.

However, if the state legislature sends it back to the governor for the second time, the governor must assent to it. The governor has the power to reserve certain bills for the president.

Q3. Answer: (c)

Article 200 of the Indian Constitution deals with the powers of the Governor with regard to assent given to bills passed by the State legislature and other powers of the Governor such as reserving the bill for the President's consideration.

Some other Articles related to the Governor of India.

- Article 153 of the Constitution requires that there shall be a Governor for each state. One person can be appointed as Governor for two or more States.
- Article 154 vests the executive power of the state in the Governor.
- Article 155 says that "The Governor of a state shall be appointed by the President by warrant under his/ her hand and seal".
- Article 156 provides that "The Governor shall hold office during the pleasure of the President". The term of the Governor is prescribed as five years.

The Governor is a part of the state legislative and can summon, adjourn or prorogue the state legislative. The governor can even dissolve the Vidhan Sabha.

At the commencement of the first session after each general election to the Legislative Assembly and at the commencement of the first session of each year the Lieutenant Governor shall address the Legislative Assembly and inform it of the causes of its summons.

As per **Article 202** of the Constitution of India the Governor of a State shall cause to be laid before the House or Houses of the Legislature of the State a statement of the estimated receipts and expenditure of the State for a financial year.

This estimated statement of receipt and expenditure for a financial year named in the Constitution as the "Annual Financial Statement" is commonly known as "Budget".
