President's rule refers to **Article 356** of the Constitution of India deals with the failure of the constitutional machinery of an Indian state.

In the event that government in a state is not able to function as per the Constitution, the state comes under the direct control of the central government, with executive authority exercised through the Governor instead of a Council of Ministers headed by an elected Chief Minister accountable to the state legislature.

**Article 356** is invoked if there has been the failure of the constitutional machinery in any states of India.

In the states, the Governor, as the representative of the President, is the head of Executive, but real executive power rests with the Chief Minister who heads the Council of Ministers. The Council of Ministers of a state is collectively responsible to the elected legislative assembly of the state.

A member of the State Public Service Commission appointed by the Governor can be removed by only the President of India.

#### Q9. Answer: (d)

Sucheta Kriplani was India's first woman Chief Minister, serving as the head of the Uttar Pradesh government from 1963 to 1967.

In October 1963, she became the Chief Minister of Uttar Pradesh, the first woman to hold that position in any Indian state. The highlight of her tenure was the firm handling of state employees strike.

The Inter-State Council was established under **Article 263** of the Constitution of India through a Presidential Order dated 28 May 1990. **Article 263** makes it clear that the Inter-State Council is not a permanent constitutional body for coordination between the States of the Union.

It can be established 'at any time' if it appears to the President that the public interests would be served by the establishment of such a Council. The Council is a recommendatory body.

The Council shall consist of Prime Minister (Chairman), Chief Ministers of all States and union territories (Member), Administrators (UT) and Six Ministers of Cabinet rank to be nominated by the Prime Minister (Member).

This is not a standing committee.
